



Silicon Valley Power Attic Insulation Rebate Application



Qualifications:

- Qualifying measures and rebate values are subject to change. Visit <http://www.siliconvalleypower.com/rebates> or call (408) 244-SAVE (7283) to verify your efficiency measure qualifies for a rebate **BEFORE** purchase or installation.
- When applicable, obtain necessary permit through the City of Santa Clara Permit Center. Please visit <http://santaclaraca.gov/index.aspx?page=2447> or call (408) 615-2400. City of Santa Clara permit must have final approval (for requested measures only) in order to receive rebate.
- Qualifying products must be installed and operating in a residence receiving electricity in the City of Santa Clara from Silicon Valley Power.
- Offer is valid on new product sales only and until available funds run out.
- Silicon Valley Power reserves the right to verify both the new product sale/installation before a rebate is issued. Approval is at the sole discretion of Silicon Valley Power.
- Application Form must be signed and postmarked within 60 days from date of purchase.
- Applicant must submit the signed Application Form with a copy of the receipt, paid invoice, or contract for the product being installed to:

Please Note:

- Rebate will appear as a one-time bill credit on the Silicon Valley Power portion of the City of Santa Clara Municipal Utilities bill after inspection of the product installation.
- Please allow 2 to 3 billing cycles from mailing date for the bill credit. If your bill credit has not been received after three (3) billing cycles, please contact SVP at (408) 244-SAVE (7283), Monday through Friday, 8:00 a.m. to 5:00 p.m., or email questions to cutcosts@siliconvalleypower.com.
- A bill credit will only be applied to active accounts. Landlords may participate for measures installed at properties located in the City of Santa Clara and receiving electricity from Silicon Valley Power.
- Discrepancies can invalidate the rebate application.
- Silicon Valley Power is not responsible for items delayed or lost in the mail.
- Silicon Valley Power disclaims any and all liability for any loss or damage which may arise as a result of the applicant's participation in this program, and makes no expressed or implied representation or warranty that the installation of the product will result in a reduction of your electric utility bill.
- Offer void where prohibited, taxed, or restricted by law.
- This program is subject to change or termination without prior notice.
- The rebate amount cannot exceed the purchase price of the product and does not include taxes or shipping costs.

Silicon Valley Power Attic Insulation Rebate Description



Description

Insulate your home's attic to receive a rebate of \$0.10 per square foot of attic space over conditioned space.

- Must be a single-family home or multi-family home with individual attic space.
- Must be currently heated through electric heating, such as heat pump or electric resistance heat.
- Existing insulation (if any) must be less than R-19 insulating value.
- Newly installed insulation must meet a minimum insulation value of R-38 or greater.
- Preapproval is required prior to purchase.
- Customers may install the attic insulation themselves or hire a contractor.
- Projects that require a building permit (involve remodeling, tearing down walls, etc.) are not eligible. It is the applicant's responsibility to determine and meet any inspection and building requirements.
- Metallic foil, radiant barrier, reflective, or foil insulation does not qualify.
- SVP will retain no liability for contractor nonperformance or late installation.
- Rebate on the improvement of existing homes only.
- New construction is not eligible.
- Projects will be inspected to verify quality of installation prior to payment. Installations that do not meet our quality assurance inspection will be denied unless the quality issue is remediated within 30 days.
- One (1) attic insulation rebate per Silicon Valley Power utility account.

Steps

1. Mail completed application
2. Once we have reviewed the application and performed the pre-inspection, we will notify you that you are pre-approved. You must complete the project within 90 days of the pre-approval date.
3. Once installation is complete, please submit a copy of the insulation invoice.
4. We will schedule and complete a quality assurance inspection to verify installation.
5. Once the installation passes the quality assurance inspection, a bill credit will be issued within one to three billing cycles.
