



# Silicon Valley Power Residential Rebate Application



## Qualifications:

- Qualifying measures and rebate values are subject to change. Visit <http://www.siliconvalleypower.com/rebates> or call (408) 244-SAVE (7283) to verify your efficiency measure qualifies for a rebate **BEFORE** purchase or installation.
- When applicable, obtain necessary permit through the City of Santa Clara Permit Center. Please visit <http://santaclaraca.gov/index.aspx?page=2447> or call (408) 615-2400. City of Santa Clara permit must have final approval (for requested measures only) in order to receive rebate.
- Qualifying products must be installed and operating in a residence receiving electricity in the City of Santa Clara from Silicon Valley Power.
- Offer is valid on new product sales only and until available funds run out.
- Silicon Valley Power reserves the right to verify both the new product sale/installation before a rebate is issued. Approval is at the sole discretion of Silicon Valley Power.
- Application Form must be signed and postmarked within 60 days from date of purchase.
- Applicant must submit the signed Application Form with a copy of the receipt, paid invoice, or contract for the product being installed to:

## Please Note:

- Rebate will appear as a one-time bill credit on the Silicon Valley Power portion of the City of Santa Clara Municipal Utilities bill. In the case of electric hot water heat pumps, the rebate will be paid by check after inspection of the product installation.
- Please allow 2 to 3 billing cycles from mailing date for the bill credit. If your bill credit has not been received after three (3) billing cycles, please contact SVP at (408) 244-SAVE (7283), Monday through Friday, 8:00 a.m. to 5:00 p.m., or email questions to [cutcosts@siliconvalleypower.com](mailto:cutcosts@siliconvalleypower.com).
- A bill credit will only be applied to active accounts. Landlords may participate for measures installed at properties located in the City of Santa Clara and receiving electricity from Silicon Valley Power.
- Discrepancies can invalidate the rebate application.

## REBATE DESCRIPTION AND REQUIREMENTS



### POOL PUMP REBATE

Purchase a Variable Speed Pool Filtration Pump and receive up to a \$100 rebate.

- Visit [www.siliconvalleypower.com/pool](http://www.siliconvalleypower.com/pool) for a list of qualifying pumps.
- Equipment and materials must be new and meet or exceed all applicable local, state and federal standards. Rewinding of motors does not qualify
- New pumps must operate with a qualifying controller. A qualifying controller is a programmable controller that meets CA Title 20 regulation requirements. Controller must be able to operate the pool pump on at least two speeds and switch speeds automatically. It also must default to the lowest speed after one normal cycle (24 hours) if temporary high speed override capability exists.
- Above ground, pond, pool cleaner/ booster, spa and water feature pumps do not qualify.
- Rebate is for pumps 3 horsepower or less, installed on existing residential, in-ground swimming pools for primary filtration only.
- New construction is not eligible.
- Projects may be inspected to verify installation prior to payment.
- One (1) rebate per Silicon Valley Power utility account.

### ELECTRIC HEAT PUMP WATER HEATER

Replace an old electric hot water heater with a new ENERGY STAR® qualified electric heat pump water heater model and receive up to a \$500 rebate.

- Pre-approval recommended.
- ENERGY STAR-qualified electric heat pump water heater only.
- A qualifying product must be installed and operating in an existing residence receiving electricity in the City of Santa Clara from Silicon Valley Power, with an existing electric storage water heater.
- New construction is not eligible.
- Applicants must obtain necessary permits through the City of Santa Clara Permit Center. Please visit <http://santaclaraca.gov/index.aspx?page=2447> or call (408) 615-2400. The City of Santa Clara permit must have final approval (for the requested measure only) in order to receive the rebate.
- One (1) rebate per Silicon Valley Power utility account for an electric heat pump water heater.
- Qualifying measure and its rebate value is subject to change. Visit <http://www.siliconvalleypower.com/rebates> or call (408) 244-SAVE (7283) to verify your efficiency measure qualifies for a rebate BEFORE purchase or installation.
- Rebate will be provided in the form of a check after inspection of the installation.
- Rebate may not exceed the actual cost of the equipment.

### CLOTHES DRYER REBATES

We have two electric clothes dryer rebates for you to choose from:

#### **ENERGY STAR® with a Combined Energy Factor (CEF) of 4.3 - 5.4 Clothes Dryer Rebate:**

Replace your old electric clothes dryer with an ENERGY STAR® electric clothes dryer with a CEF between 4.3 and 5.4 and receive a rebate up to \$100.

#### **ENERGY STAR® with a CEF > 5.4 Clothes Dryer Rebate:**

Replace your old electric clothes dryer with an ENERGY STAR® electric clothes dryer with a CEF greater than 5.4 and receive a rebate up to \$200.

Qualifications for both rebates:

- Rebate will appear as a one-time bill credit on the Silicon Valley Power portion of the City of Santa Clara Municipal Utilities bill.
- New construction is not eligible.
- Offer is only valid for replacing an existing electric dryer with a new electric dryer that is ENERGY STAR-qualified and has a CEF of 4.3 or greater.

- One (1) electric dryer rebate per Silicon Valley Power utility account.

### CEILING FAN

Purchase an ENERGY STAR qualified ceiling fan with at least one light and receive up to a \$35 rebate per fan.

- ENERGY STAR® logo from packaging must be attached with the application.
- New construction is not eligible.

Projects may be inspected to verify installation prior to payment.

Up to three (3) ceiling fan rebates per Silicon Valley Power utility account.
