



# Income Qualified Pre-Owned Electric Vehicle Rebate Program Rules

## Eligibility

- Must be a Silicon Valley Power residential customer enrolled in the [Financial Rate Assistance Program prior to date of purchase](#). Income verification must have been provided within the prior 12 months.
- Offer is valid on pre-owned electric vehicle purchases made on or after July 1, 2023 for as long as funds remain available.
- Qualified vehicles must:
  - Be purchased from a licensed dealership
  - Have a sale price of \$25,000 or less
  - Have a gross vehicle weight rating of less than 14,000 pounds
  - Have battery capacity of least 7 kilowatt hours
  - Have a model year at least two years earlier than the calendar year when you buy it
    - For example, a vehicle purchased in 2023 must be a model year of 2021 or older
- Note: to receive a Federal Tax Credit, the vehicle must meet requirements set by the IRS and be on the [Index of Qualified Manufacturers and Previously Owned Clean Vehicles](#).
- A bonus \$1,000 rebate is available for electric vehicles that with an MPGe greater than or equal to 117.
- Customer intends to use the electric vehicle for personal use only. Company vehicles and resales are ineligible.
- The electric vehicle must be registered in the account holder's name with the Department of Motor Vehicles at the residential address listed in your Silicon Valley Power account.
- The rebate application must be signed and postmarked within 60 days from the date of purchase.
- Limit of one rebate per Silicon Valley Power customer every five years.
- One rebate per vehicle identification number. Electric vehicles that previously received a Silicon Valley Power electric vehicle rebate under the previous owner are not eligible for this rebate.
- Discrepancies can invalidate the rebate application.
- Silicon Valley Power is not responsible for items delayed or lost in the mail.
- Silicon Valley Power disclaims any and all liability for any loss or damage which may arise as a result of the applicant's participation in this program.
- Offer void where prohibited, taxed, or restricted by law.
- This program is subject to change or termination without prior notice.
- The rebate amount cannot exceed the net purchase price of the product after any other discounts or incentives and does not include taxes or shipping costs.
- Rebates valid for purchases made with United States currency only.

## Payment

- Rebate amounts are \$1,500 for pre-owned all-electric vehicles and \$1,000 for pre-owned plug-in hybrid electric vehicles.
- Bonus rebate of \$1,000 for customers who meet the LIHEAP income qualifications.
- Bonus rebate of \$1,000 available for electric vehicles that meet MPGe eligibility.
- Rebates will be mailed as a check within 6 to 8 weeks after all required documents have been received.

## Required Documents

- Rebate application
- Copy of the paid invoice showing the cost of the electric vehicle
- Copy of DMV Bill of Sale
- Copy of the vehicle registration
